### Additional Details About our Emissions and Targets

Comments: -

Data is collated January to December.

Upstream deliveries are calculated from suppliers address worldwide.

Kebomed UK do not own any delivery vehicles.

**2020** – Due to the global pandemic (Covid-19) our sales order book reduced significantly resulting in reduction of staff, staff travel, purchase of stock and the need for couriers & freight forwarders to deliver products.

**2021** - The pandemic still influenced our order book & travel but signs of improvement.

**2022** – Business activity starting to get back to pre-Pandemic levels, no travel restrictions.

**2023** - Business activity back to pre-Pandemic levels, we have 2 new members of staff & new product portfolio added to KUK offering.

**2024** – Mid 2024, KUK diversified adding a new Enteral feeding division to its portfolio. Which will increase the team size, supplier portfolio, stock holding and upstream / downstream deliveries.

### **Kebomed UK carbon reduction initiatives, environmental management measures and projects.**

- Our environmental management system across the UK is UKAS certified to ISO 14001:2015 and is audited annually. It focuses on objectives and actions on areas that will have the most significant environmental impact both in the short and long term.
- Continuously work to collect the highest quality, primary data on our emissions to aid in reduction and progress measurement.

### **Head office & Warehouse**

- We undertook an internal energy audit with our landlord, resulting in a number of improvements to be made e.g., instillation of solar panels, new electricity supply, lighting & heating improvements etc.
- Our site has contracted new electricity provider which supply's 100% renewable electricity for the next 5 years.
- Office lighting changed to LED timed lighting controls have been installed.
- New eco-friendly heating & cooling systems installed in office areas.
- Electronic equipment turned off overnight.
- Waste generated through our operations is sorted so a minimal amount goes into landfill.
- Office recycling bins are in place e.g., paper, plastic, tin, food waste etc.
- New Local recycling firm contracted to collect all dry recycling. We are working to reduce this by: - reusing any cardboard boxes, working with suppliers to reduce the amount of packaging they use.
- We currently estimate we recycle / reuse /repurpose 100% of all incoming cardboard, paper & plastic packaging.
- Introduction of Multi-Functional Devices for all to use rather than one each e.g., office printers and scanners will be reduced in number in the office and upgraded to more energy efficient models.
- Data storage upgraded and cloud based.
- Implement paperless office.
- Printing only when necessary; double sided.
- All paper purchased must be 100% recycled.

## Team

- We have run a communications campaign to educate and drive awareness around events such as World Environment Day.
- We have contracted an e-learning platform with all our team.
- We have built awareness amongst our team of the impact of their decisions on our journey to net zero by holding firm wide engagement sessions.
- Reduce business travel by air, rail, and road through effective measurement and a sustainable travel policy.
- Improve scheduling of meetings and positioning of sales staff to reduce distances travelled and multiple visits to a city/region.
- Switch road/air travel to rail
- Review company car purchasing & convert to hybrid or electric where possible.
- Where own car used for business, we send encourage & recommendations for hybrid or electric car.
- Send annually driving Safer Driving and Fuel-Efficient driving tips.
- Reduced commuting mileage/fossil fuel mileage – increased use of public transport and walking/cycling; electric company cars; electric car charging points; cycle-to-work scheme
- Introduction of remote/hybrid working for office staff.
- Reduce domestic and international business travel by encouraging online meetings
- Use greener hotels

## Supply chain

- We have built sustainability into our procurement processes and include Environment and Net Zero questions as part of supplier selection process & annual supplier questionnaire audit.
- Work with suppliers to understand their own emissions and encourage them to set their own carbon reductions targets in line with the science.
- Look at local supply options.
- Reduce the number of international deliveries.
- Work with key individuals on CRP such as working suppliers to reduce emissions to achieve net 0.
- We are working on making all product literature available electronically & via Kebomed UK website rather than only printed.
- We are asking / working with our suppliers whether they can replace / have available their printed DFU's for electronic QR codes / electronic links.

## Transportation

- All freight forwarder / couriers are to hold an environmental policy, carbon reduction plan.
- When choosing the freight forwarder / courier, choose the most eco-friendly route sea, air, road.

Kebomed UK Leadership team are committed to KUK reaching our targeted reduction plan and remain confident that our current and future measures will enable us to achieve our target reduction in advance of 2045. Due to the nature of our business to reach Net Zero Kebomed will look to invest in Carbon offsetting initiatives.

The carbon emission reduction achieved by these schemes and changing the way we work since 2019 have resulted in reduction of 793 tons of CO<sub>2</sub>e which is a 49% reduction against the 2019 baseline.

Over the next ten years we plan to implement further measures which will continue to drive down emissions. We aim to reduce emissions by a minimum of 4% each year. **Scope 1** 168kg CO<sub>2</sub>e, **Scope 2** 112kg CO<sub>2</sub>e and **Scope 3** 344kg CO<sub>2</sub>e
